EMPLOYER TUITION BENEFIT

Grants & Scholarships

Unlike loans, grants and scholarships <u>do not need</u> to be repaid. Not all students are eligible for grants or scholarships, students should still apply to determine if they are eligible.

INSTITUTIONAL GRANT

MASS GRANT

MASS Grant is awarded by the Commonwealth of Massachusetts to eligible full-time students. MASS Part-Time grants are awarded **by Urban College of Boston** to eligible students who complete at least 6 credits but no more then 12 credits for the Fall and Spring Semesters. **Students must complete the FAFSA to be considered for both grants.**

EARLY CHILDHOOD EDUCATORS (ECE) SCHOLARSHIP

This scholarship is designed to provide financial assistance for currently employed early childhood and 'out of school time' educators and providers who enroll in an associate, bachelor or master's degree in Early Childhood Education or related programs.

Student must complete the FAFSA and ECE Application by the deadline to be considered.

TUITION FREE COMMUNITY COLLEGE (TFCC) PLAN

The City of Boston covers up to three years of tuition and fees for Boston residents ages 18-24 who are pursuing an associate degree or eligible certificate program. In general, students may be eligible if they are:

- A Boston Resident.
- Between the ages of 18 24.
- Received a High School Diploma or its equivalency.
- If eligible, must complete the FAFSA
- Continuously enrolled (students who withdraw or take a leave of absence lose their eligibility for the grant)

For undocumented students, TFCC will provide last dollar tuition and fee funding for up to \$2,500 per student each semester for up to three years.
